Intended use: The ROHO® Hybrid Elite SR™ Single Compartment Cushion (Hybrid Elite SR) and ROHO® Hybrid Elite® Dual Compartment Cushion (Hybrid Elite Dual Compartment Cushion) is an adjustable, air-filled, wheelchair support surface combining a ROHO DRY FLOATATION® cellular design cushion insert with a contoured foam base and is intended to conform to an individual's seated shape in the pelvic loading area to provide skin/soft tissue protection, positioning, and an environment to facilitate wound healing. There is a weight limit of 500 lbs. (225 kg), and the cushion must be properly sized to the individual. The Hybrid Elite must be used with the supplied cover.
